# Waterworks District 9 Ward 4 Meeting Minutes Regular Board Meeting Monday, February 12, 2024 5:30 pm – Conference Room

The Board of Directors met in a regular meeting on Monday, February 12, 2024, in the conference room located at 4015 Sherry Street, Sulphur, LA., with President Kent Chamblee presiding with the following members present: Richard Boenig, Steve Belshe, Kent Chamblee, Theresa Bell. Ray Taylor was absent.

The Invocation was led by Theresa Bell followed by the Pledge of Allegiance.

# Eddie Robinson & Jake Smith – Insurance Unlimited

- Eddie presented the property insurance renewal for 2024/2025 to the board. He informed the board that our policy and rate are very good.
- Eddie and Jay performed another walk through to double check covered buildings. Jay is to have signs made and hung on buildings for identification purposes.
- Still waiting to get a quote for Cyber Liability. Cyber Policy will be back dated due to premium being due on 2/15/2024 and we have yet to get a quote.
- Richard Boenig asked about the generator being listed in the policy. Eddie is to check to see if generator is listed and if not, he will have generator listed as a line item.
- There was a motion by Theresa Bell and seconded by Richard Boenig to pay the insurance premium of \$120,485.32. Motion carried.

# Lee Lancon – Lancon Engineers, Inc. Engineering Report

- Water Storage Tank Rehab Project Status (see engineers report)
  - final payment has been made.
  - Lee recommends taking the towers out of service for inspection, to inspect the inside.
- Water Storage Tank Rehab (Phase 2) (see engineers report)
  - Lee presented quotes Jay received to replace wall panels around filters and to install a canopy over the filters. There was a motion by Theresa Bell and seconded by Steve Belshe to accept the bid from Well Hung Metal, to include a free-standing canopy, in the amount of \$28,952.32. Motion carried.
- 2023 Water Line Upgrade Project (ARP Funds)
  - Still waiting to hear back from the parish.

There was a motion by Steve Belshe and seconded by Theresa Bell to go into executive session. Motion carried.

There was a motion by Steve Belshe and seconded by Theresa Bell to return to regular session. Motion carried.

- Burton Shipyard Road Water Line Relocation (see engineers report)
  - Waiting for approval from Bob Kleinschmidt to sign cancelation of easement.

There was a motion by Theresa Bell and seconded by Richard Boenig to go into executive session. Motion carried.

There was a motion by Steve Belshe and seconded by Theresa Bell to return to regular session. Motion carried.

## Kelly Riley – Reports

- **Minutes** Minutes were reviewed. There was a motion by Steve Belshe and seconded by Richard Boenig to approve the minutes as presented. Motion carried.
- **Payables** Payables were reviewed and discussed. There was a motion by Richard Boenig and seconded by Steve Belshe to approve payables as presented. Motion carried.
- **Profit & Loss** Reviewed and discussed. Theresa made the board aware of journal entries that were made by the CPA. The board is not comfortable with why entries were dated so far back. Kelly is to set up a meeting with the CPA to discuss what is happening. Theresa and Kent would like to be at the meeting with the CPA also.
- **LAMP Funds** Reviewed and discussed. Kelly mentioned it was time to move money from the operating account to a LAMP account. There was a motion by Theresa Bell and seconded by Richard Boenig to move money from the operating account to the LAMP Construction account bringing operating account balance to \$600,000.00. Motion carried.
- **Policy Manuel** Tabled till next meeting.
- **Bank Bidding** After some discussion, there was a motion by Theresa Bell and seconded by Richard Boenig to change the operating account from JP Morgan Chase to JD Bank. Theresa Bell recommended waiting on transferring money into LAMP account until after most of the checks have cleared the Chase account. \$500,000 will be used to open the new Operating Account at JD Bank. Both accounts will be run parallel for a few months, giving Kelly time to get everything changed over and make sure all autodrafts are drawing appropriately.

## Jay Picard – Plant/Field Updates

- Water Line down Miller After some discussion, the board chose to complete the loop with a 6" water line and fire hydrant. Due to the amount being over the dollar threshold, Jay will get two more bids.
- **Tie In Well #3** Jay is still waiting for additional quotes. The board approved for Jay to proceed when quotes come in.
- Improved Security for Office/Plant (cameras, glass upgrade, improved door) No progress.
- **New Employee** Jay let the board know he hired another operator, Braiden Young.

There was a motion by Steve Belshe and seconded by Richard Boenig to adjourn the meeting. Motion carried.

## LEI Project No. 19-007 Water Storage Tanks Rehabilitation

- 1. Construction is now complete, and the following is a general summary of construction work completed since last report:
  - 1.1. EWST #1 Volunteer Road
    - 1.1.1. All work completed.
  - 1.2. EWST #2 Mosswood Drive
    - 1.2.1. All work completed.
  - 1.3. Project Status
    - 1.3.1. Project final Reconciliation Change Order No. 7 has been fully executed and recorded with the Calcasieu Parish Clerk of Court. Original of the fully executed change order and recordation information has been provided to the Contractor and Water District.
    - 1.3.2. Contractor's final pay application has been submitted to the Water District with a recommendation for final payment by the Engineer.
    - 1.3.3. Project is now complete. The one (1) year warranty period is set to expire on July 20, 2024. Accordingly, a warranty inspection of the elevated water tanks should be conducted before that date. LEI has set a notification of the inspection for May 21, 2024, and it is recommended that the Water District do the same so that the inspection can be completed in advance of the July 20, 2024 deadline.

## LEI Project No. 19-007 Water Storage Tanks Rehabilitation (Phase 2)

- 1.1. The project began advertising on Friday, January 26, 2024, and bids will be received at the office of Lancon Engineers on Thursday, February 22, 2024. A non-mandatory pre-bid meeting is scheduled for Wednesday, February 14, 2024, at the office of WWD#9.
- 1.2. To date, bidding documents have been issued to four (prime bidders) including:
  - 1.2.1. Pittsburg Tank and Tower, Hendersen, KY
  - 1.2.2. Maguire Iron, Inc., Sioux Falls, SD
  - 1.2.3. Utility Service Co., Inc., Perry GA
  - 1.2.4. Phoenix Fabricators & Erectors, Avon, IN
- 1.3. Discuss issues with filters and building wall penetrations. Recommended that owner solicit quotes to remove existing flashing to allow inspection of filter wall and coating system at wall penetrations and replace flashing with temporary flashing that will be removed and replaced by painting contractor and then remove and replace building insulation and sheeting on the entire

wall and permanently flash the filter wall penetration. Review the following quotes received by Jay Picard.

### LEI Project No. 18-002, Burton Shipyard Road Water Line Relocation

1. Review of the Easement Termination Affidavit document submitted by Kelly Malone revealed a problem that needs to be corrected before that document is approved by the Board. The problem involves the easements under paragraph C and D of the document. Those easements were obtained from Stephen Kent Vallette across property at the NW corner of the intersection of Burton Shipyard Road with Olsen Road. As per the documents the easements are described as being 10' in width and are located across the Vallette property; however, their specific location is not identified. The District had an existing line along the north side of Burton Shipyard Road which has been abandoned and has an existing line along west side of Olsen Road that is still in service. Due to the ambiguity of the easement legal descriptions for both line it is not possible to determine which easement is associated with the line along Olsen Road. Mack Gregorie, attorney for Driftwood, wants to have both easements abandoned and Driftwood grant a new easement for the line along Olsen Road. To make sure the easement width is sufficient he is having the line located by Fenstermaker and they will establish the easement width to include the line and prepare a plat and legal description for Mack's use in preparing the new Easement Instrument. I agree with this approach and recommend that no action be taken on the Affidavit of Termination document until the new Easement Instrument has been prepared by Mack, reviewed by me and Bob, and recommended for approval by the Board by Bob. I will also have Bob review the Affidavit of Termination document concurrent with his review of the new Easement Instrument. Update-Received new Easement Instrument from Mack Gregorie. Sent it to Bob Kleinschmidt on 2/2/2024 and again on 2/12/2024 and am waiting on his authorization of approval by the Board.
